The applicants agree that:

- 1) at the moment of invoice payment and the electronical mark in CSDD, the objects' OCTA and CASCO policy may become void (as a result the new owner should buy a new policy), therefore the person, indicated in the policy, should independently control the validity of the policy;
- 2) if the Object insurance premium has been divided into parts according to the payment schedule, CASCO policy of the Object will be terminated at the end of the month, during which the final invoice has been issued;
- 3) ownership rights for the asset mentioned in the Agreement and all related risks transfer to the Client or the Third party (if the final invoice is issued to the third party) at the moment when the final invoice is paid and no separate delivery – acceptance act for ownership transfer shall be prepared;
- 4) If the asset is the object registered in the Road Traffic Safety Directorate (CSDD) after the final invoice has been paid SIA "UniCredit Leasing" makes the electronic alienation mark within the Car register. The recipient of the asset undertakes within 3 (three) working days from the moment when the electronic alienation mark has been made and according to the mark to register his/her ownership rights for the asset in CSDD.
- 5) If the third person to whom the final invoice is issued does not pay it in term, the Client undertakes to continue to fulfill all obligations arising from the Agreement and the Loan agreement (if concluded) according to the provisions of these agreements.
- 6) the existing Object holder is fully responsible for all duties related to the tax payments applicable to the Object, and making of electronic mark in the CSDD Vehicle Register and object removal from the register for the purpose of re-registration may not be possible if all the taxes related to the Object have not been paid or Object has any foreclosures/ encumbrances. Before requesting the final invoice, please verify status of tax payments at <https://e.csdd.lv/>

The third party in addition certifies that:

- 1) Agrees to everything mentioned in the application and wants to buy the asset mentioned in the Agreement, as well as undertakes to repossess the asset from the Client for his/her own expense;
- 2) Agrees that the purchase deal of the asset mentioned in the Agreement shall be treated as concluded at the moment when SIA „UniCredit Leasing” issues the final invoice to a person mentioned in this application.
